The 2018 Impact Assessment of CMS Quality and Efficiency Measures

## **Project Overview:**

Section 3014 of the Patient Protection and Affordable Care Act (ACA) requires that the U.S. Department of Health and Human Services (HHS) conduct an assessment of the quality and efficiency impact of the use of National Quality Forum-endorsed measures, described in Section 1890(b)(7)(B) of the Social Security Act. The Centers for Medicare & Medicaid Services (CMS) has contracted with Health Services Advisory Group, Inc. (HSAG), as part of the Measure & Instrument Development and Support (MIDS) Contract (Contract #: HHSM-500-2013-13007I; Task Order #: HHSM-500-T0002) to conduct a comprehensive assessment and evaluation of the impact of the use of quality and efficiency measures implemented in the Medicare Program.

CMS intends to release and make public a comprehensive report (Impact Report) once every three years. The first report was published in March 2012; the second report was published in March 2015. The report will address key CMS quality measurement topics. As required by its contract with CMS, HSAG is convening a TEP of stakeholders and healthcare providers to contribute direction and input on the development of the third triennial report, scheduled for publication in 2018. The individuals listed in Table 1 were selected and have agreed to serve as the TEP for this project.
