### **Web-Based Training**

The Medicare Learning Network offers a series of Web-Based Training courses.

To access a course, first go to the MLN. Scroll down to Web Based Training Modules and click the link.

Find your course in the listing on the left. Stars indicate that continuing education credits are available.

For the purpose of this example, let's log in as a return user. After successfully logging in, you'll arrive at a Welcome page. Next click Web-Based Training Courses. By clicking on Introduction, you can begin. Courses may include knowledge assessments where you can test what you have learned.

# **Submitting Claims**

Claims submission can be a complex process and it's common to have questions.

Are these the correct codes? Have I filled in the required information? When are these claims due?

Because understanding claims submission is pivotal to receiving reimbursement, CMS developed a number of easy-to-understand, timely and official products to help you.

# **Health Information Technology**

From the upgrade to ICD-10 to exchange of information through Electronic Health Record (EHR) technology, the nation's health care system is undergoing transformation.

Under the Health Information Technology for Economic and Clinical Act, or the "HI-TECH Act," CMS will provide incentive payments to eligible health care professionals and hospitals as they adopt, implement, upgrade or demonstrate meaningful use of certified EHR technology. The Medicare EHR Incentive Program starts in 2011 and continues through 2016.

### **Product Ordering System**

CMS offers materials in print and electronic formats absolutely free through the Product Ordering System. By completing certain Web-Based Training courses, you can even earn Continuing Education Units or CEUs.

Ordering a product is quick and easy. First go to the Medicare Learning Network web page at <a href="http://www.cms.gov/mlngeninfo">http://www.cms.gov/mlngeninfo</a>.

Then scroll down to the Product Ordering Page.

Search by topic and keyword to find the products that are right for you. Or, browse the comprehensive list. Let's say that you are interested in learning more about CMS websites related to Medicare. The CMS Website Wheel is an informational resource you would definitely want to order.

Once you have selected your product, a new window will appear on your screen.

To order a product, you'll need to login or register. Once you log in, you'll be taken to a Welcome screen.

From here, click the Request A Product tab in the middle of your screen. Then search by topic or key word again or just scroll down to find your product.

Add the product to your cart and check out. You'll be able to verify your address before completing your order.

When you see the order confirmation screen, you will know that the product is on the way.
