DATA NOTE: UPDATED 2020 INCASSET SEGMENT

Introduction

To facilitate research using Medicare Current Beneficiary Survey (MCBS) data on the income and assets of Medicare beneficiaries, CMS released an updated version of the Income and Assets (INCASSET) segment of the MCBS Survey File Limited Data Set (LDS) for the 2020 data year. The purpose of this Data Note is to describe the differences between the original and updated versions of this MCBS data segment.

Overview

The INCASSET segment of the MCBS Survey File LDS contains detailed information on the income and assets of beneficiaries and their spouses/partners (if applicable). This information is collected from MCBS Community respondents through the Income and Assets Questionnaire (IAQ) during each summer data collection period. The original version of the INCASSET segment of the 2020 MCBS Survey File LDS was released in June 2022 and is documented in the *2020 MCBS Data User's Guide: Survey File*. The updated version of the INCASSET segment was released in the fall of 2022. Both versions of this segment contain equivalent data on Medicare beneficiaries and can be used for analysis. However, CMS recoded select variables and removed variables containing duplicative information from the updated version of this segment to improve its analytic usability for researchers.

Scope

CMS updated 15 variables and removed 35 redundant variables from the updated version of the INCASSET segment. Exhibit 1 lists the affected variables and briefly describes the changes. See the Codebook for more information on the variables on this segment.

Notes: SSRR stands for Social Security retirement and/or Railroad Retirement. SSI stands for Supplemental Security Income. VA stands for Veteran's Administration.

Impact

Moving forward, the updated version of the INCASSET segment will be included in the 2020 MCBS Survey File LDS, which is available with a Data Use Agreement (DUA). Researchers can submit a request for the 2020 MCBS Survey File LDS via CMS' DUA tracking system, the Enterprise Privacy Policy Engine (EPPE).
