**SUBJECT:** Contract Year (CY) 2027 Plan Benefit Package (PBP) Industry Testing

This memo provides technical guidance for the upcoming CY 2027 PBP module and application programming interface (API) testing activities.

**PBP API Testing**

---

Starting on **January 6, 2026**, plan and consultant users may begin testing the CY 2027 PBP API on the HPMS sandbox website (<https://hpmssandbox.cms.gov>).

Comments on the PBP API must be submitted to the HPMS API Technical Support team at [hpmstechsupport@triafed.com](mailto:hpmstechsupport@triafed.com). The subject link must include the following: CY 2027 PBP API Testing Comment

All plan organizations and consultants must use the HPMS API Key Management module on the HPMS plan testing sandbox website to request, generate, and manage HPMS API keys to be used solely for testing purposes.

## PBP Module Testing

---

Starting on **January 6, 2026**, plan and consultant users may begin *previewing* the CY 2027 PBP module on the HPMS sandbox website. While users will have full access to the PBP functionality, CMS is treating this as a preview window, as industry comments will not be collected. This functionality will be temporarily disabled starting at 5:00 p.m. ET on Friday, January 30, 2026 to prepare the module for the formal test period.

Beginning on **February 2, 2026**, plan and consultant users may begin formal CY 2027 PBP module testing on the HPMS sandbox website. The test window will end on **March 3, 2026**. The PBP module will be available at <https://hpmssandbox.cms.gov> for testing.

As a reminder, new plan and bid consultant users must submit a request to obtain access to the HPMS sandbox site. There are three access types available by request:

Access Type Name	Description
<b>PBP Data Entry (2139)</b>	Allows designated plan and consultant users to perform data entry in the Plan Benefit Package (PBP) for their assigned contract numbers.
<b>PBP View-Only (2140)</b>	Provides designated plan and consultant users with read-only access to the Plan Benefit Package (PBP) for their assigned contract numbers.
<b>PBP Reports (2142)</b>	Provides designated plan and consultant users with access to the Plan Benefit Package (PBP) reports for their assigned contract numbers.

### To obtain module access as a direct plan employee:

- The plan organization must send an email to the [hpmssconsultantaccess@cms.hhs.gov](mailto:hpmssconsultantaccess@cms.hhs.gov) mailbox requesting access to the HPMS sandbox for PBP testing. This email must include the user name(s), CMS user ID(s), organization name, applicable PBP access type(s), and contract number(s) for which this access is needed.

### To obtain module access as a bid consultant:

- The sponsoring plan organization must follow the routine instructions for establishing a bid consultant user in HPMS, as outlined in the HPMS memo sent on April 11, 2025 entitled “Instructions for Requesting Consultant Access to the Health Plan Management System (HPMS).”

- If the bid consultant user needs the ability to access the PBP on the HPMS sandbox website, the sponsoring plan organization must clearly request the assignment of one or more of the PBP access types on the HPMS sandbox in the official letter.
- If the user also needs to perform PBP API testing, the sponsoring organization should include the appropriate API access types in the official letter. Refer to the HPMS API Key Management User Guide for more information.

## Testing Schedule

---

Below is a recap of the PBP testing schedule:

Date	Event
January 6, 2026 - March 3, 2026	CY 2027 PBP API testing.
January 6, 2026	Start of CY 2027 PBP module preview for plan and consultant users.
February 2, 2026 - March 3, 2026	Formal CY 2027 PBP industry test window.

We strongly encourage users to submit API and module comments as soon as possible so that they can be considered for the production release in early April 2026.
