

## **Rural Health Clinics (RHCs)/Federally Qualified Health Centers (FQHCs)** **Continued Efforts over the Past Years**

### ***Definition of an Rural Health Clinic (RHC) and a Federally Qualified Health Center (FQHC)***

Medicare-certified rural health clinics (RHC) are located in a rural areas designated as a shortage area, is not a rehabilitation agency or a facility primarily for the care or treatment of mental diseases. Federally qualified health centers (FQHC) are located in both rural/urban areas designated as a shortage area.

RHCs operate exclusively for the purpose of providing primary care services to Medicare patients located in rural and shortage areas; FQHCs provide primary care services and dental care services to rural/urban areas and shortage areas. Both RHCs and FQHCs must comply with the applicable Medicare health and safety standards found at 42 CFR Part 491, including the Conditions for Certification/Coverage (CfCs). There are approximately 4400 Medicare-certified RHCs and 8400 Medicare-certified FQHCs.
