**SUBJECT:** Contract Year 2023 Part D Pricing File Submission Application Programming Interface Changes

This memo provides early notice of some upcoming technical changes to the Health Plan Management System (HPMS) Part D Pricing File Submission (PDPFS) application programming interface (API). These changes will apply to the Contract Year (CY) 2023 Part D pricing submissions, beginning with the test submissions in early July 2022. The ongoing CY 2022 PDPFS API submissions will remain unchanged.

**Submitting Files**

The updated PDPFS API call for submitting files will be structured as follows:

For reference, the current API call structure for submitting files is provided in **Appendix A**.

The specific changes are listed below:

1. URL changed from /api/pdpfs/RemoteOperations/uploadPricingFile to /api/pdp/v1/submission-records/submit
2. Removed ContractId Header
3. Removed TestSubmission Header
4. Moved ContractYear from Header to form data with change in casing

**NOTE:** The primary change is moving the URL and the ContractYear parameter from the header to the form data. Plans may continue to submit the ContractId and TestSubmission headers, but they will be ignored by HPMS.

### **Fetching the Submission Status**

The updated PDPFS API call for fetching the submission status will be structured as follows:

1. URL changed from /api/pdpfs/RemoteOperations/checkSubmissionStatus to /api/pdp/v1/submission-statuses/confirmation-numbers
