**SUBJECT:** Release of Contract Year 2023 Medicare Advantage (MA) and Prescription Drug Benefit (Part D) and Related CY 2023 Applications & Deadlines

CMS announces the release of materials for the 2023 Medicare Advantage (MA), Prescription Drug Plan, and Employer/Union-Only Group Waiver (EGWP) Plan and the Special Needs Plan (SNP) application. Applications are now posted on the CMS websites listed below and will be available for completion in the Health Plan Management System (HPMS) on January 12, 2022. All applications (excluding PACE applications) must be completed in HPMS by 8:00 p.m. EST on February 16, 2022. All materials and supporting documentation must be submitted through HPMS.
