SUBJECT: Release of Contract Year 2022 Medicare Advantage (MA), Medicare-Medicaid Plan (MMP), and Prescription Drug Benefit (Part D) and Related CY 2022 Applications & Deadlines

CMS has released PDF documents and associated supporting materials for the 2022 Medicare Advantage, Prescription Drug Plan, Employer/Union-Only Group Waiver Plan, and Medicare-Medicaid Plan applications and the Special Needs Plan application. Applications are now available on the CMS websites listed below and will be available for completion in CMS' Health Plan Management System (HPMS) on January 13, 2021. All applications (excluding PACE applications) are due to CMS by 8:00 p.m. EST on February 17, 2021. All materials and supporting documentation must be submitted through HPMS.

As a reminder, CMS will be offering trainings on the Part C and D applications on January 13th and January 19th Part C&D User Group calls. The Medicare-Medicaid Coordination Office will provide a separate training to MMP applicants.
