**SUBJECT:** 2023 Data Validation of Medicare Part C and Part D Reporting Requirements Data

As provided under 42 C.F.R. §422.516(g) and §423.514(j), Part C and Part D sponsors must participate in annual retrospective data validation (DV) of the Part C and D reporting requirements data. In order to ensure the reliability of the data reported, each Part C and D sponsor must select a DV reviewer (contractor) to conduct the audit independently.

Per the Medicare Part C and D Reporting Requirements Data Validation Procedure Manual Appendix A: Standards for Selecting a Data Validation Contractor, we remind sponsors that in order to ensure the independence of the DV contractor, sponsoring organizations (SOs) may not use their own staff to conduct the DV review. Also, companies that provide management consulting or assist the SO with its reporting procedures, reporting processes, or information systems used in storing, compiling, or reporting the Part C and/or Part D Reporting Requirements data to CMS may not serve as the DV contractor for that SO for any given reporting period. Management consultation activities include performing mock audits, pre-assessments, and any other types of reviews on reported data. Exhibit 1 in Appendix A provides additional guidance on whether an entity's relationship with an SO meets CMS' standard for organizational independence in conducting the DV review.

The 2023 DV cycle will take place from April 1 to June 30, 2023, for 2022 data submitted for the following reporting sections by March 31, 2023: Part C Grievances, Organization Determinations/Reconsiderations and Special Needs Plans (SNPs) Care Management; and Part D Grievances, Medication Therapy Management Programs (MTM), Improving Drug Utilization Review Controls (DUR), and Coverage Determinations/Redeterminations. Data submitted or re-submitted after March 31, 2023, cannot be used for purposes of the DV. The deadline for reviewers to submit annual DV findings to CMS is June 30, 2023.
