

**PlanCrosswalk2022\_10042021.xlsx** or **PlanCrosswalk2022\_10042021.txt** – This dataset, available in both Excel and tab delimited text formats, contains the Contract Year (CY) 2021 to CY 2022 plan crosswalk associations identified by plan organizations via the HPMS plan crosswalk module. This file also contains any other plan crosswalk associations approved by CMS.
