

CJR PRO Performance Year 7 Data Submission Overview

For successful submission of Comprehensive Care for Joint Replacement (CJR) patient-reported outcomes (PRO) data in performance year (PY) 7, hospitals must submit post-operative data for patients who received elective primary total hip arthroplasty (THA) and/or total knee arthroplasty (TKA) in PY 6 **and** pre-operative and risk variable data for patients undergoing an elective primary THA/TKA in PY 7.

All pre- and post-operative PRO data submitted in PY 7 should be entered into the **PY 7 CJR PRO Data Collection Template** and submitted using Managed File Transfer (MFT) between August 1, 2023, and September 30, 2023.

POST-OPERATIVE DATA TO SUBMIT IN PY 7

Hospitals should submit post-operative data for procedures performed **during the PY 6 performance window** (July 1, 2021 to June 30, 2022).

- Data should be submitted for **at least 80% or at least 300** of the eligible primary THA/TKA procedures performed during PY 6.

Post-operative data must be submitted on **the same patients** for whom hospitals submitted pre-operative PRO and risk variable data in PY 6 so that:

- Hospitals have submitted **matched pre- and post-operative data** for at least 80% or at least 300 of the eligible primary THA/TKA procedures performed during the PY 6 timeframe, July 1, 2021, to June 30, 2022.

Post-operative data should be **collected 270 to 425 days after the eligible procedure**.

PRE-OPERATIVE DATA TO SUBMIT IN PY 7

Hospitals should submit pre-operative data for procedures performed **during the PY 7 performance window** (July 1, 2022 to June 30, 2023).

- Data should be submitted for **at least 85% or at least 400** of the eligible primary THA/TKA procedures performed during PY 7.

Hospitals are strongly encouraged to collect pre-operative and risk variable data for **more** procedures than the required minimum. Doing so will increase a hospital's chances of success:

- In PY 7, in case a submitted procedure does not meet eligibility requirements.
- In PY 8, in case a hospital is not able to obtain post-operative data for all procedures for which they submit pre-operative data in PY 7.

Pre-operative data should be **collected 90 to 0 days prior to the eligible procedure**.
