SUBJECT: Release of Updated Medicare Advantage and Part D Contract and Enrollment Public Website Reports

CMS has implemented some recent updates to the Medicare Advantage/Part D Contract and Enrollment Data section resident on the CMS public website at:

The recent updates include the following:

- We have modified the existing **Monthly Contract and Enrollment Summary Report** to add the following breakout tables: a) Special Needs Plan (SNP) enrollees vs. non-SNP enrollees per contract type, and b) employer-only enrollees vs. non-employer-only enrollees per contract type.
- We have added a new data file entitled **Monthly Enrollment by Contract/Plan/State/County** to provide monthly enrollment counts at the contract/plan/state/county level. Cell counts with values at 10 or below are suppressed. This data file also provides descriptive information on the contracts and plans, such as the organization type, plan type, Part D plan indicator, SNP indicator, and employer-only plan indicator.
- We have modified the publishing schedule for the existing **Enrollment by Plan** report. Specifically, we are now publishing this report on a monthly basis rather than annually.
- We have added two new data files entitled **MA State/County Penetration** and **PDP State/County Penetration**. These monthly data files compare MA and PDP enrollment against Medicare eligibles at the state/county level to produce market penetration rates.
- We have modified the existing **SNP Comprehensive Report** to include plan segments.

Report / File Name	Description
UPDATED - Monthly Contract and Enrollment Summary Report	Provides the number of contracts, MA only enrollment, Part D enrollment, and total enrollment by organization type. This report contains all organization types.
Monthly Enrollment by Contract	Provides monthly enrollment for each contract. This report contains all organization types.
NEW - Monthly Enrollment by Contract/Plan/State/County	Provides monthly enrollment at the contract/plan/state/county level for all organization types.
UPDATED - Monthly Enrollment by Plan	Provides monthly enrollment at the contract/plan level for all organization types.
Monthly MA Enrollment by State/County/Contract	Provides monthly enrollment at the state/county/contract level for all organization types except for PDP and employer-direct PDP. Note: An abridged version is also provided that excludes rows with 10 or less enrollees.
Monthly PDP Enrollment by State/County/Contract	Provides monthly enrollment at the state/county/contract level for PDP and employer-direct PDP organizations. Note: An abridged version is also provided that excludes rows with 10 or less enrollees.
NEW - MA State/County Penetration	Provides MA market penetration rates at the state/county level.
NEW - PDP State/County Penetration	Provides PDP market penetration rates at the state/county level.
MA Contract Service Area by State/County	Provides contract service area by state and county for all organization types except for PDP and employer-direct PDP.
PDP Contract Service Area by State/County	Provides contract service area by state and county for PDP and employer-direct PDP organizations.
State Service Area	Provides the list of states covered in whole or in part by each contract. This file contains all organization types.
Enforcement Actions	Provides data on enforcement actions taken by CMS against MA and PDP organizations since January 2006.

Report / File Name	Description
Corrective Action Plans	Provides data on corrective action plans requested from MA and PDP organizations in response to audits and other ad-hoc compliance activities.
UPDATED - Special Needs Plan (SNP) Data	Provides monthly plan enrollment for each SNP and provides totals by SNP type.
HEDIS Public Use Files	Provides annual Medicare Health Plan Employer Data and Information Set (HEDIS) performance measures.
MA Plan Directory	Provides a plan contact for each MA, cost, PACE, and demo organization. Note: This directory is populated using the Plan Directory Contact for public web site field maintained by organizations in HPMS.
PDP Plan Directory	Provides a plan contact for each PDP organization. Note: This directory is populated using the Plan Directory Contact for public web site field maintained by organizations in HPMS.
MA Claims Processing Contacts	Provides a claims processing contact for each MA, cost, PACE, and demo organization. Note: This directory is populated using the MA Claims Processing Contact field maintained by organizations in HPMS.
