Thanks to the #InflationReductionAct, also known as the prescription drug law, Medicare is able to directly negotiate with drug companies to lower the prices for certain high-cost and highly used prescription drugs covered under #Medicare Part D for the first time. Medicare successfully negotiated new, lower prices for 10 drugs that will go into effect in 2026! Through the #InflationReductionAct Medicare Drug Price Negotiation Program, 10 drugs will now have new, negotiated lower prices, resulting in \$1.5 billion in estimated out-of-pocket savings in 2026 for people with Medicare prescription drug coverage.
