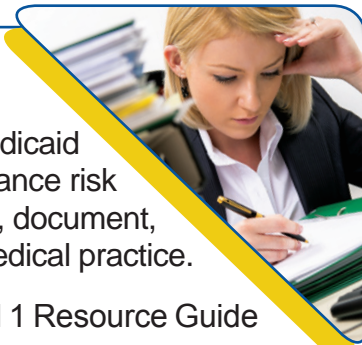


Audit Toolkit

Target Audience: Medical professionals and State Medicaid agencies.

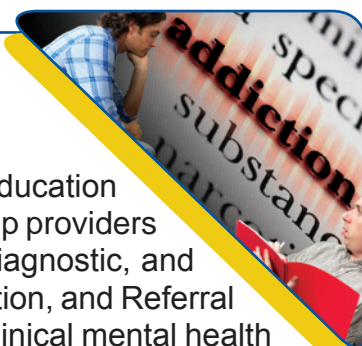


Behavioral Health Services Toolkit

Target Audience: Behavioral health providers, family physicians, community mental health centers, and State Medicaid agencies

Purpose: The Behavioral Health Services materials provide important and current education on billing for behavioral health care services in a variety of settings. The materials help providers understand how to bill for basic services such as Early and Periodic Screening, Diagnostic, and Treatment (EPSDT) services for those under 21 years old; Screening, Brief Intervention, and Referral to Treatment (SBIRT) for those with substance use disorders; and community and clinical mental health services for all ages.

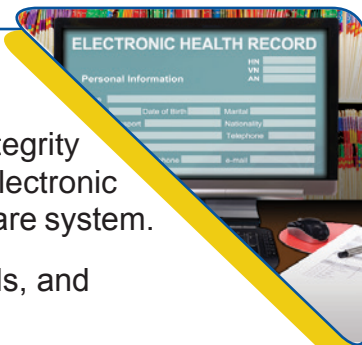


Electronic Health Records Toolkit

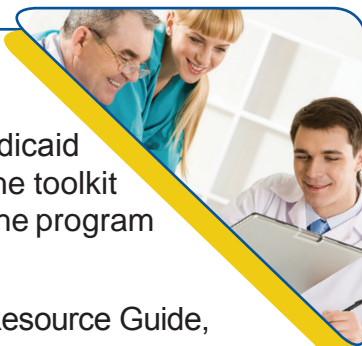


Fraud, Waste, and Abuse Toolkit

Target Audience: Medical professionals and State Medicaid agencies

The toolkit also informs providers of Medicaid fraud prosecutions and settlements and some of the program integrity measures taken by government agencies.

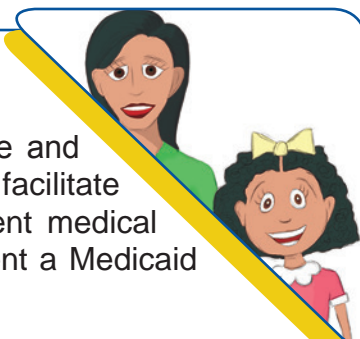


Medicaid Compliance for the Dental Professional Toolkit

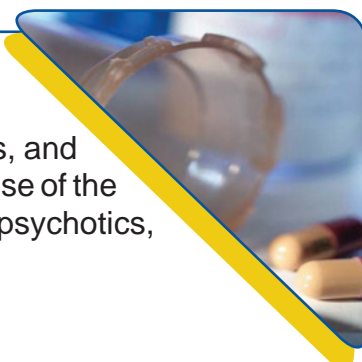


Pharmacy Education Toolkit

Target Audience: Prescribing physicians, pharmacists, and State Medicaid agencies

Purpose: The Pharmacy Education materials provide the FDA-approved uses, risks, and potential adverse effects and applicable boxed warnings for both adult and pediatric use of the following drug classes: anticonvulsants, antidepressants, stimulants, atypical antipsychotics, proton pump inhibitors, and enoxaparin.

Pharmacy Auditing and Dispensing Toolkit

Target Audience: Private and institutional pharmacy managers and State Medicaid agencies

The materials help pharmacies audit incoming prescriptions for validity and authenticity, manage controlled substances stock and distribution, manage invoices to compare inventory to expected product on hand, and audit billing and distribution practices like partial fills that may be prone to errors.
