December 17, 2012 - Use of CDC's 2008 Table 1: Life Table

The Centers for Disease Control (CDC) has published its 2008 United States Life Tables. Effective January 19, 2013, the Centers for Medicare & Medicaid Services (CMS) will begin referencing the CDC's Table 1: Life table for the total population: United States, 2008, for WCMSA life expectancy calculations. This means that for any newly submitted WCMSA proposal received by CMS' Coordination of Benefits Contractor (COBC), uploaded via the Web portal, or where any WCMSA case is reopened on or after January 19, 2013, CMS will apply the CDC's 2008 Table 1 for life expectancy calculations.
