The spreadsheet contains **3** tabs. The first tab describes the data contained within each tab of the spreadsheet. The second tab includes final Worksheet S-3, Parts II and Parts III wage data from cost reports for Fiscal Year (FY) 2008 (FY Begin Dates from 10/1/07 to 9/30/08). It excludes non-IPPS providers and Critical Access Hospitals (CAHs). The third tab includes July 2007-June 2008 occupational mix survey data, which was used to compute the occupational mix adjusted wage indexes for the FY 2012 IPPS final rule. Additionally, there are **two** text files corresponding to each tab above to meet Section 508 compliance.
