3-55 & 3-56	29a	Change format	Grouped the instances when Item 29a should be coded and grouped the instances when Item 29a should not be coded
3-55 & 3-56	29a	Clarify coding & add sentences	This item is for the purposes of nutrition and hydration. “Do not include IV fluids administered during a diagnostic procedure,” “Do not include IV fluids used to reconstitute medications for IV administration” to definition

3-59	31	Delete sentence and add	“Open lesions/sores may develop because of circulatory problems, pressure, or in association with other diseases such as syphilis” and replace with “Skin ulcers that develop because of circulatory problems or pressure are coded here” in definition
3-59 & 3-60	31	Clarify	Replace “an ulcer/open lesion” with “a skin ulcer” (several places)

3-61	31	Delete sentence and phrase	"Four ulcers are consistent with Stage 2 ulcer staging and one ulcer appears to be at Stage 3. Assuming that the patient in this scenario has no pressure ulcers," in 2 nd example

3-64	33	Add phrase	"pressure or circulatory" to describe ulcers in Intent
3-65	33b	Delete	"Other Than Ulcers, Rashes, Cuts" from item title
3-65	33b	Delete sentences (and Add)	"Code here any open lesions/sores that are not coded elsewhere in Items 31 and 33. Do NOT code skin tears or cuts here" and replace with "Include skin ulcers that developed as a result of diseases and conditions such as syphilis and cancer. Do NOT code skin tears or cuts, abrasions or bruises, burns (from any cause), and rashes here" to definition
3-65	34a&b	Add phrase	"pressure reducing and pressure redistributing devices" to definitions
3-66	34e	Delete phrase (and add)	"an ulcer at any stage" and replace with "skin problems coded in Items 31, 32, & 33b " in definition
3-69	38	Add phrases	"or diagnostic" and "or post-procedure" to intent
3-72	38bc	Add phrase	"and treatments when permitted by the state nurse practice act" to definition
3-76	39	Delete	"exercise" from 5 th bullet
3-77	39b	Delete sentence (and add)	"When patients do most of the modality, but need some assistance with the final stretch, it is still considered active range of motion" and replace with "Include active ROM and active assisted ROM. Any participation by the resident in the ROM activity should be coded here" in definition

3-85	42	Add	“When physician orders a limited number of days of therapy, then the projection is based on the actual number of days of therapy ordered. For example, if the physician orders therapy for 7 days, the projected number of days in Item 42b will be 7” as a 3 rd bullet
