CMS invites all Medicare Advantage (MA), demonstration, 1876 cost, PACE, and Prescription Drug Plan (PDP) organizations and certifying actuaries to provide feedback on the Contract Year (CY) 2009 bid submission process in the Health Plan Management System (HPMS). CMS is also soliciting feedback on the CY 2009 actuarial bid requirements. Specifically, we are seeking comments and suggestions regarding the following areas:

- Plan Benefit Package/Summary of Benefits (PBP/SB) software;
- HPMS Bid Submission module, which includes functions such as plan creation, bid upload, plan and formulary crosswalks, substantiation and actuarial certification uploads, and service area verification;
- Medicare Advantage (MA) Bid Pricing Tool (BPT);
- Prescription Drug (PD) Bid Pricing Tool (BPT);
- Two Year Lookback Form;
- CMS instructions regarding the completion of the BPTs;
- Actuarial certifications, documentation requirements, and any other actuarial issues related to the bidding process; and
- HPMS bid and benefit reports.

CMS has scheduled the feedback period to take place from Monday, August 11, 2008 through Friday, September 5, 2008. As with prior years, an online Internet application is available to support the collection of your comments and suggestions.
