**SUBJECT:** CY2013 Pricing Data Requirements – Request for Comments

Each spring, CMS releases the Medicare Plan Finder (MPF) Pricing Requirements document for the upcoming contract year. The requirements document describes the pricing data Part D sponsors will submit during regular submission windows which will display on the MPF. The purpose of this memo is to solicit comments and suggestions for the proposed changes to the MPF Pricing Data Requirements for CY2013. Your early feedback will help ensure a common understanding of specific data elements that will foster consistency in the submission of data by all Part D sponsors, and ultimately help improve the prescription drug cost data displayed on the MPF tool. Your initial comments and recommendations will help CMS prepare comprehensive pricing data requirements for CY2013.

Specifically, CMS is soliciting comments on the proposed changes to the pricing data requirements as summarized below:

## • PC File:

• Removing Pharmacy\_LA\_Drugs, Pharmacy\_HI, and Pharmacy\_LTC fields. Every year, CMS evaluates the pricing data requirements. At this time, CMS will be removing the Pharmacy\_LA\_Drugs, Pharmacy\_HI, and Pharmacy\_LTC indicators as the data are not utilized in the estimated drug cost on the MPF.

## • PF File:

- Removing Unit\_Cost and Unit\_Cost\_90 fields. These will be replaced with a single field, Unit\_Cost.
- Adding a Days\_Supply field to indicate if the pricing is for a 30, 60, or 90 day supply. The current pricing data requirements only allow for submission of unit\_cost for a 30 day retail supply and unit\_cost\_90 for a 90 day mail order supply. This change will allow plans to submit pricing for a 60 or 90 day retail supply and a 30 or 60 day mail order supply. By displaying 30/60/90 day supply retail/mail order, beneficiaries will have access to additional pricing information about a plan, such as one that offers a 90 day supply at retail.
- Adding an Is Mail field to indicate if the pricing is for a mail order pharmacy.
- Adding Ceiling\_Price and Ceiling\_Quantity fields. These fields would indicate the ceiling price and quantity for a specific NDC. Ceiling pricing reflects an agreement

between a plan sponsor and a pharmacy to charge a specific amount for a defined list of medications at a defined fill quantity and applies to every phase of the Part D benefit. The ceiling price is set below the standard plan co-pay for those medications in order to provide an additional cost savings for the beneficiary.

We would appreciate feedback on these changes as we further refine the elements for the MPF CY2013 Pricing Data Requirements.
