

Qualified Registries for the 2012 Physician Quality Reporting System (PQRS) and Electronic Prescribing (eRx) Incentive Programs

CMS is pleased to announce the registries that have become “qualified” to submit quality data to CMS on behalf of their eligible professionals for 2012 PQRS reporting. Each of these registries has completed a thorough vetting process which includes: checking their capability to provide the required PQRS data elements, reviewing measure flows and algorithms to perform use case calculations (this checks to see whether the registry calculates the measure’s reporting and performance rates correctly), and transmitting the required information in the requested file format (XML). Only existing 2011 PQRS measures and measures groups that are included in the 2012 program year are listed in this Qualified Posting.

Vendors will have the opportunity to complete testing the new 2012 measures and measures groups during the Spring of 2012. An updated list of measures and measures groups will be posted once this has been completed.

There is a new self-nomination process currently underway which will allow additional registries to become “qualified” for 2012 PQRS and eRx participation. The vetting process and posting of the names of these new registries will be completed during the summer of 2012.

Finally, if you do not see that name of a registry you worked with in the past, please check the list of 2012 qualified Data Submission Vendors which will be posted in the summer of 2012.
