

**Qualified Electronic Health Record (EHR) Direct Vendors for the 2013
Physician Quality Reporting System (PQRS) and Electronic Prescribing (eRx) Incentive Programs**

CMS is pleased to announce the 2013 Physician Quality Reporting System EHR Direct vendors and their systems (including specific version or release). These systems have been “qualified” to submit quality data to CMS by eligible professionals (EP) for the 2013 PQRS program year. Each of these EHR Direct vendors completed a thorough vetting process to verify that their system has the capability to provide the required data elements for the 51 PQRS EHR measures. A list of the 51 EHR measures may be found in the EHR Measure Specifications Manual located within the “2013 EHR Documents for Eligible Professionals” .zip file. This .zip file can be found on the section page entitled “Electronic Health Record Reporting” on the CMS PQRS website, available at <http://www.cms.gov/Medicare/Quality-Initiatives-Patient-Assessment-Instruments/PQRS/Electronic-Health-Record-Reporting.html>.

Some EHR Direct vendors are also capable of reporting the Electronic Prescribing (eRx) Incentive Program and the Medicare EHR Incentive Pilot to CMS as listed in the following table.

Eligible professionals who wish to participate in the 2013 Physician Quality Reporting System, Electronic Prescribing Incentive Program and/or the Medicare EHR Incentive Pilot using the EHR-based reporting option may contact the EHR Direct vendors listed on the following pages for additional details about their software. Please note: Eligible Professionals will need an Individuals Authorized Access to the CMS Computer Services (IACS) account to submit data directly from the EHR to CMS. The data submission period for program year 2013 is currently scheduled for January 1, 2014 to February 28, 2014.
