The Center for Medicare and Medicaid Innovation (Innovation Center) is excited to announce that 51 Direct Contracting Entities (DCEs) are participating in the Implementation Period of the Direct Contracting Model for Global and Professional Options, which runs from October 1, 2020 through March 31, 2021. The Implementation Period provides an opportunity for DCEs to prepare for the first Performance Year (PY1), which starts on April 1, 2021. All 51 DCEs participating in the Implementation Period will have the opportunity to participate in PY1, along with DCEs that applied to start participation beginning in PY1. The DCEs will serve beneficiaries in 39 states as well as in the District of Columbia and Puerto Rico.
