SUBJECT: Notice of Direct Contracting Entities Participating in Performance Year 2021 of the of the Global and Professional Direct Contracting (GPDC) Model

The Center for Medicare and Medicaid Innovation (Innovation Center) is excited to announce that 53 Direct Contracting Entities (DCEs) are participating in Performance Year 2021 (PY2021) of the Global and Professional Direct Contracting (GPDC) Model, which starts April 1, 2021. The DCEs will serve Medicare fee for service beneficiaries in 38 states as well as in the District of Columbia and Puerto Rico. 39 of these DCEs have selected the Global risk sharing option and 14 have selected the Professional risk sharing option. These 53 DCEs include multiple DCE types with 31 Standard DCEs, 16 New Entrant DCEs, and 6 High Needs Populations DCEs.
