**A. Background:** CWF adjudicates Medicare claims and generates responses. The response records are large and each record contains fixed header portion and variable trailers portion. To test the CWF software changes, the developers and/or testers utilize ITF as an online tool to create and process claims. Currently, ITF displays limited header and trailer information on the online screens and users are unable to see the full response until a batch cycle is executed.

The Centers for Medicare & Medicaid Services is directing CWF to enhance ITF responses for developers and testers to quickly identify issues, if any, during testing.
