A. Background: The Health Insurance Master Record (HIMR) inquiries require entry of a valid Host Identifier (ID) by a user if the Medicare beneficiary record is not at the local Host for that Health Insurance Claim (HIC) or Medicare Beneficiary Identifier (MBI) number. Currently, the user has to manually look at each of the nine CWF Hosts by providing Host ID, which also results in duplication of inquiries.

CMS is directing the CWF maintainer to auto-locate the Medicare beneficiary records and display in HIMR when the records are not present at the local Host or at the Host ID provided by the user.

B. Policy: There are no new policy changes with this CR.
