The process to initiate background checks and provide PIV cards will require individuals at the contractors to interact directly with the Department of Health and Human Services approved mobile PIV station computer system. Individuals located less than 50 miles from CMS Central Office in Baltimore can interact with the computer systems at CMS; however, selected contractors located more than 50 miles away from CMS will have the mobile PIV station computer systems installed at and operated by personnel who work for the selected contractors. This CR is for NGS to install and operate a mobile PIV station computer system at the NGS offices located at 8115 Knue Road, Indianapolis, IN 46250.
