## I. GENERAL INFORMATION

#### A. Background:

Under the Medicare Durable Medical Equipment, Prosthetics, Orthotics, and Supplies (DMEPOS) Competitive Bidding Program, beneficiaries with Original Medicare who obtain competitive bidding items in designated competitive bidding areas (CBAs) are required to obtain these items from a contract supplier, unless an exception applies. Section 30.7 of Chapter 20 of the Medicare Claims Processing Manual (Pub. 100-02) states that the supplier that collects the last month of rental (i.e., 15th month) for an enteral nutrition pump is responsible for continuing to furnish, maintain and service the pump after the 15<sup>th</sup> rental month. Business requirement 5487.10.1 of The National Competitive Bidding (NCB)—Phase III of Implementation Change Request (CR) 5487, states that maintenance and servicing may be performed by any supplier , regardless of their status as a winning or non-winning supplier.

#### **B.** Policy:

If an enteral nutrition pump was rented for less than 15 continuous months by a non-contract supplier at the time of the implementation of the competitive bidding program, the rental of the pump will transition to a contract supplier. The contract supplier will be paid the remainder of the rental months and subsequent maintenance and servicing payments.

If an enteral nutrition pump was rented for at least 15 continuous months at the time of the implementation of the competitive bidding program, the contract or non-contract supplier that provided the item in the 15th month of the rental period is responsible for furnishing, maintaining and servicing the enteral nutrition equipment after the 15<sup>th</sup> rental month until medical necessity ceases or the end of the reasonable useful lifetime (RUL) of the equipment is reached, whichever is earlier.

For non-contract suppliers that received payment for the 15th rental month prior to the implementation of the competitive bidding program, the Medicare payment amount for maintenance and servicing of enteral nutrition equipment is equal to 50 percent of the fee schedule amount for one month's rental of enteral nutrition equipment. For contract suppliers, the Medicare payment amount for maintenance and servicing of enteral nutrition equipment is equal to 5 percent of the single payment amount for the purchase of enteral nutrition equipment.

Prior to making payment to the non-contract supplier for maintenance and servicing, the contractors must verify that the non-contract supplier received payment for the 15th rental month prior to the start of a competitive bidding round.

This Change Request (CR) will allow the shared system maintainer to pay maintenance and servicing to both contract and non-contract suppliers for the enteral pumps that they furnish to beneficiaries in the 15<sup>th</sup> month of continuous service. The CR includes instructions to reprocess claims with dates of service between January 1, 2011 and December 31, 2011.
