Currently FISS has established a segregation of security duties in the FISS online system. Only designated security personnel have the ability to update the Operator Control File that limits the functions and screens accessible by each operator. Conversely, security personnel are not allowed to have any other access within the FISS system, which maintains the hard segregation.

Hewlett-Packard Enterprise Services (HPES) would like to extend this segregation to other areas within the FISS system, moving functions tied to operators or security over to the "security" profile.
