A. Background: The purpose of this notification is to inform the Novitas Solutions, Inc., the contractor that processes IHS hospital claims, that the Office of Management and Budget approved the rates listed in the attachment to this notice. The IHS published the Outpatient Per Visit and Medicare Part B Inpatient Ancillary Per Diem rates in the Federal Register on April 8, 2014. However, Novitas Solutions, Inc. did not have CMS approval to make payment adjustments for the changes in the outpatient rate and the ancillary Part B rate.
