**SUBJECT: Allow Zoned Program Integrity Contractors (ZPICs) to Access Medicare Administrative Contractors (MACs) by ZPIC Zone**

**I. SUMMARY OF CHANGES:** In some instances, there are only two organizational roles to access MAC's claims data and reports: Program safeguard contractor (PSC) and MAC. PSCs are transitioning to ZPICs. A MAC region may include several ZPIC zones (home health/hospice and DME only). This change request will allow access to a MAC's claims data by multiple PSCs and each PSC/ZPIC to produce reports that concern only claims for the PSC/ZPIC zone.

**EFFECTIVE DATE: APRIL 1, 2010, FOR CONTRACTORS USING MCS AND FISS SHARED SYSTEMS AND APRIL 1, 2011, FOR CONTRACTORS USING THE VMS SHARED SYSTEM.**

**SUBJECT: Allow Zoned Program Integrity Contractors (ZPICs) to Access Medicare Administrative Contractors (MACs) by ZPIC Zone**

**EFFECTIVE DATE: APRIL 1, 2010, FOR CONTRACTORS USING MCS AND FISS SHARED SYSTEMS AND APRIL 1, 2011, FOR CONTRACTORS USING THE VMS SHARED SYSTEM.**

**IMPLEMENTATION DATE: APRIL 5, 2010, FOR CONTRACTORS USING MCS AND FISS SHARED SYSTEMS AND APRIL 4, 2011, FOR CONTRACTORS USING THE VMS SHARED SYSTEM.**

The MCS shared system shall perform analysis and design for the January 2010 release and implement the changes in the April 2010 release. In April MCS will complete coding and implement the location related changes and reporting these locations for CPT/other than clean claim.

The MCS will implement some aspects of this change request after April 5, 2010. Once the reporting requirements are finalized, MCS will review and devise a ballpark. MCS and CMS will then schedule out the changes for implementation. MCS is looking at the reporting changes for the July 2010 Release.

The VMS shared system shall implement the changes in the July 2010 release.

## I. GENERAL INFORMATION

**A. Background:** In some instances, there are only two organizational roles to access MAC’s claims data and reports: Program safeguard contractor (PSC) and MAC. PSCs are transitioning to ZPICs. A MAC region (home health/hospice and DME only) may include several only ZPIC zones. This CR will allow access to a MAC’s claims data by multiple PSCs/ZPICs and each PSC/ZPIC to produce reports that concern only claims for the PSC/ZPIC zone.

This One-Time Notification expands Transmittal 501, Change Request 6430, dated June 5, 2009, to apply the requirements to all shared systems.

**B. Policy:** A MAC region may encompass several ZPIC zones. For example, a ZPIC may be responsible for MAC claims from only a subset of states in a MAC. However, 45 CFR Part 164 Section 512(d) (ii) and (iii) authorizes ZPICs to extract and analyze data for all MACs for health care oversight activities.
