SUBJECT: VMS and FISS Analysis – Changes in Capped Rentals for DME Due to the Deficit Reduction Act of 2005

I. GENERAL INFORMATION

A. Background: The VMS and FISS systems to conduct a systems analysis based on recent legislative changes mandated by section 5101(a) of the Deficit Reduction Act (DRA) of 2005. Since 1991, suppliers of capped rental items have been required to offer beneficiaries the option of taking over ownership of the item after 15 months of continuous use. In addition, suppliers have been required to give beneficiaries the option of obtaining power wheelchairs on a lump sum purchase basis. If the beneficiary did not elect the lump sum purchase option for the power wheelchair, the power wheelchair is furnished in a rental basis, but the beneficiary could still elect to take over ownership of the item after 15 months of continuous use like other capped rental items.

Section 5101(a) of the DRA of 2005 mandates that, effective for capped rental DME items for which the first rental month occurs on or after January 1, 2006, suppliers must transfer title to the equipment to the beneficiary on the first day after the 13th continuous month of use during which payment is made for the item. The lump sum purchase option for power wheelchairs is unchanged by this provision; however, in those cases where a beneficiary does not elect this option, the new rules regarding transfer of ownership also apply to power wheelchairs for which the first rental month occurs on or after January 1, 2006.

B. Policy: Effective for capped rental DME items for which the first rental month occurs on or after January 1, 2006, suppliers must transfer title to the equipment to the beneficiary on the first day after the 13th continuous month of use during which payment is made for the item. If the beneficiary does not elect the lump sum purchase option for power wheelchairs, the new rules regarding transfer of ownership will apply to power wheelchairs for which the first rental month occurs on or after January 1, 2006.

Contractors shall make payment for reasonable and necessary maintenance and servicing (i.e., parts and labor not covered by a supplier's or manufacturer's warranty) of patient owned capped rental equipment in accordance with instructions located at Pub. 100-02, the Medicare Benefit Policy Manual, section 110.2, of chapter 15. The billing instructions located at section 130.7, of chapter 20, of the Medicare Claims Processing Manual also apply to claims for maintenance and servicing of capped rental items. No payment shall be made for maintenance and servicing of rented equipment for which the first rental month occurred on or after January 1, 2006.
