- If registering for an Alternative Payment Model (APM) Entity, skip ahead to that section.

**2025 Final Document text:**

1. Click **APM Entities** or **Practices** (most users will only see one option available) to view a list of associated organizations you can access.

- If registering for an APM Entity, skip ahead to that section.

*You can filter by registration status or search by the practice name if you have multiple organizations associated with your account.*

2. Locate the organization under which you wish to register. From here, you can select the option to register a group, individual, or subgroup.

Pursuant to this regulation, CMS may only use or disclose personally identifiable information to the extent that such information is necessary to carry out their statutory and regulatory mandated functions.
