R2012Q100 HETS 270/271 Release Summary of Impact on Trading Partners

The purpose of this summary document is to inform submitters of upcoming changes to the HIPAA Eligibility Transaction System (HETS) 270/271 application. The R2012Q100 HETS 270/271 release will address adding/removing data elements for the HETS 270/271 application for the **5010A1** version only.

Please refer to the following details for additional information.

1. Preventive Data

Discontinued HCPCS codes

The HETS 270/271 application is being modified to no longer return discontinued/terminated HCPCS codes for preventive services. The following discontinued/terminated codes will no longer be returned in the EB13 segment of the 2110C Loop.

- G0107
- G0344
- G0366
- G0367
- G0368
- G0203
- 76091
- 77052

The following is an example of the 2110C Loop with a valid active HCPCS code:

2. Rehabilitation Services

New Technical and Professional Component Data for Pulmonary, Cardiac and Intensive Cardiac Rehabilitative Services

The HETS 270/271 application is being modified to identify and return the following rehabilitative services information:

- The number of remaining sessions for both the Technical and Professional Components for Pulmonary Rehabilitation and
- The number of sessions used for both the Technical and Professional Components for Cardiac and Intensive Cardiac Rehabilitation.

These components will be identified by accompanying MSG segments if present. The 271 may return both, either or no Technical or Professional Components for the Rehabilitation Services. The verbiage of the existing MSG segments for Intensive Cardiac Rehabilitation services has been updated, while the MSG segments for Pulmonary and Cardiac Rehabilitation services are new as of this release.

Following is an example of the EB03 segment in the 2010C Loop identifying the changes.

3. Plan Type

New MCO Pay Bill Option of '51'

The HETS 270/271 application is being modified to return the Medicare Advantage (MCO) Plan Type Code = 'PR' (Preferred Provider Organization) in the EB04 segment of the 2110C Loop when the beneficiary is enrolled in a Medicare Advantage plan with a MCO Pay Bill Option Code equal to '51'.

The following is an example of the EB03 segment in the 2110C Loop:
