**RE:** Results of the 2018 Part C and D Reporting Requirements Data Validation

Organizations contracted to offer Medicare Part C and/or Part D benefits are required to submit data to the Centers for Medicare and Medicaid Services (CMS) per the Medicare Part C and D Reporting Requirements. The data are subject to validation through an independent yearly review in order to ensure they are reliable, valid, complete, comparable, and timely. The data validation reviews of contract year (CY) 2017 Medicare Part C and D data were conducted between April 1, 2018 and June 30, 2018, and we are pleased to announce the results of those reviews.

A total of 553 Medicare Advantage contracts and stand-alone Prescription Drug Plans completed data validation. Validation of contracts with both Part C and Part D benefits was conducted on 480 contracts, validation of contracts with Part C-only benefits was conducted on 14 contracts, and validation of contracts with only Part D benefits was completed on 59 contracts. Table 1 below contains a statistical summary of the data validation scores.

Table 2 presents the distribution of the overall data validation scores. A total of 2 contracts (0.4%) scored below 95% (rounded to the nearest whole number). In comparison, 6 contracts scored below 95% in the 2017 data validation cycle of CY 2016 plan-reported data.

Contracts scoring below 95% on the overall Part C, Part D, or combined score and in active status in CY 2018 will be required to submit remediation plans to CMS and will be contacted by CMS in the near future.

Table 3 displays the distribution of the overall Part C data validation scores. Out of 494 contracts, 12 (2.4%) scored below 95%.

Table 4 contains the distribution of the overall Part D data validation scores. Out of 539 contracts, 2 (0.4%) scored below 95%.

Table 5 displays a statistical summary of the data validation scores by reporting section. Improving Drug Utilization Controls had the highest mean score (99.87%) and Special Needs Plan Care Management had the lowest mean score (99.53%).

A total of 15 contracts (2.7%) scored below 95% for overall average and/or below 95% for Part C average, and/or below 95% for Part D average, and/or below 95% on all three scores.
