Specification Updates

Purpose and Scope

This document illustrates the differences between the HEDIS® 2013 Patient-Level file specifications (2012 Measurement Year) and the HEDIS® 2014 Patient-Level file specifications (2013 Measurement Year) documents. Again this year, we will be collecting two documents: File 1 consists of all measures except the Plan All Cause Readmissions (PCR) measure, which is contained in File 2.

Additions and Deletions to the 2014 File Specifications

There were no deletions or additions to the Medicare measures for HEDIS 2014, file layouts remain unchanged from the HEDIS 2013 specifications for both File 1 and File 2.
